Newton Election Procedures Face Restructuring

The Newton Election Commission has two new members, Stephen Smith (R) and Fay Cohen (D) who were appointed by Mayor David B. Cohen earlier this year in response to reports of problems and irregularities with the November 4, 2000 elections. The new chairperson, Attorney David Mofenson (D), is a longterm member of the Commission.

Frances Shaer (R) is the fourth member. At its June 20 meeting, the Commission specifically asked for input from the LWVN on redrafting a mission statement and action plan proposed by the Commission and its executive secretary, Alan Licarie. The LWVN Local Action Committee is now involved in this task.

The Commission expecially welcomed suggestions that it modernize procedures for educating and training election workers, develop new methods of recruiting workers, increase accuracy and speed of reporting election results, and comply with relevent state statutes governing local elections.

Specific areas for change include:

A manual for workers. LWVN and the Commission propose to develop an Operations and Training Manual for election workers and for the staff working in the Newton Election Commission office. Such a manual would be given to workers at their training sessions. It would also be available at the polling places on election day as a resource for solving problems that arise.

Recruitment efforts. Current methods are insufficient to staff the polls. Efforts to increase the pool of potential workers should include advertising in local media and via citizen organizations, newsletters, and educational institutions.

Hours for workers. People can work in shifts. Hours can be arranged with the Newton Election Commission and with the Warden of the polling place.

Voters' Service-Preliminary Election

A preliminary election is scheduled for Tuesday, September 11, 2001, with polls open from 7 a.m. to 8 p.m. On the ballot will be contests for the Ward Alderman races in Wards 2 and 4 to narrow the field to two candidates for each ward. There is one preliminary race for the School Committee in Ward 5 which will result in two candidates for the November election ballot.

New Ward Lines to be in Place for Future Elections

t its July 9 meeting, the Newton Board of Aldermen approved (11 yes, 10 no; 2 absent; 1 vacancy) new ward and precinct lines to comply with state requirements that precincts be substantially equal in population following each federal census. The new lines change some residents in Wards 5 and 6, and will place School Committee candidate Patricia Kellogg, now running from Ward 5, in Ward 6 and competing with another incumbent School Committee member in the 2003 election. It keeps Alderman Ken Parker's house in Ward 6, vs. the original Ward Committee (Ald. Lines George Mansfield, Chair) proposal which placed his house in Ward 5.

Ald. Leonard Gentile (W3) filed a motion to reconsider the vote taken on July 9, and a Special Meeting for this purpose was held on Thursday July 19 from 7:00 - 8:30 pm. After considerble discussion and debate, the Aldermen voted (10 yes, 13 no, 1 vacancy) against a motion to substitute the original Ward Lines Committee proposal for the one approved on July 9. The Board then approved (14 yes, 9 no, 1 vacancy) the boundaries originally passed on July 9.

During work on the drawing of new ward and precinct lines, it was discovered that the lines on the current "Ward Map" of the City of Newton do not correspond with the actual city ordinance that was approved a decade or two ago laying out descriptions of the current ward lines. Nor does the "Street List" (a printed document, listing each street in the city alphabetically, showing which house numbers are in which ward and precinct) correspond to the actual city ordinance. Thus, Ald. Ken Parker, elected as a resident of Ward 6, has actually been living in Ward 5 since he purchased his house about 3 years ago. This information came to light during June, after the Ward Lines Committee approved its original new proposal on May 22, 2001.

The City's Law Department and the Election Commission are now working on how to resolve this problem. The

League has been advised that several hundred voters will be notified by postcard that they must vote at a different polling place for the Sept 11 and Nov 6, 2001 elections. The new boundaries just approved by the aldermen will take effect on January 1, 2002. They still require formal approval from a state agency and/or the Secretary of State's Office. ■

Regional Transportation Study and Land Use

Deb Crossley's hard work at the LWV State Convention in April alerted other leagues to the need for a new Transportation Study. As a result of her efforts, many delegates lobbied for such a study, but it did not get the twothirds vote necessary to be adopted as a non-recommended item.

The interest shown at convention encouraged Sandy Findar, State League Chair, to convene a meeting at the LWVM office in Boston to consider "concerns and issues" on June 28. A thorough discussion of possibilities for the future and the need to recognize some of the complex issues associated with transportation were met with enthusiasm. A further meeting will be held September 13, at the Newton Free Library at 6:30 P M.

Area transportation advocates are lining up in support of a Newton lawmaker's bill to encourage more commuters to use public transit and car-pooling programs. The legislation would provide expanded tax breaks to businesses offering benefits such as subsidized MBTA passes and van pools to reduce the number of employees who drive to work. "It's a recognition of the fact that we ought to be encouraging people to take advantage of the commuter rail and ride sharing." said State Senator Cynthia S. Creem of Newton, chief sponsor of the bill.

Three large and important petitions for Special Permit and Site Plan Approval are currently before the Aldermanic Land Use Committee. All three have had public hearings before the Committee:

Terraces LLC at Andover Newton on Herrick Road has petitioned for forty-two single family attached dwellings and six single detached dwellings with 113 parking spaces on 552,226 square feet of land, zoned single residence 3. The petitioner has asked for an extension of time until September. A number of issues with the Langley Road Coalition have not been resolved.

The Roman Catholic Archbishop of Boston and the Emerald Development Group are petitioning for nine single family attached dwellings and the development of thirty-five units of affordable elderly housing at 243 Watertown Street, Nonantum, on approximately 54, 193 square feet of land in Multi Resident two district. Traffic is a concern.

The Pillar House Redevelopment Group by National Development Group has outlined plans to move the Pillar House original structure to a new site on Washington Street, Newton Lower Falls. It would be replaced with a 122,000 square feet office building and garage. The parcel contains 94,648 square feet. However, the July 21 Boston Globe carried an article reporting that the Massachusetts Highway Department will take the parcel by eminent domain for "safety reasons". The site is deemed a traffic hazard.

His Honor the Mayor has requested the sum of \$8,000 be appropriated to Budget Reserve and expended for the purpose of contracting with the Massachusetts Institute of Technology, Department of Urban Studies and Planning, for work on the Land Use and Transportation elements of the City of Newton Comprehensive Plan. ■

Calls to the Secretary of State's office and to other communities reveal that there appear to be no statutory requirement that election workers serve for the entire day until the ballots are completely counted. On the contrary, the Towns of Action and Concord have, for years, hired workers in shifts. An official in Acton commented that there is no way the town could find enough workers without allowing them to work only part of the day. The Secretary of State's office confirms that nothing prohibits such part-day workers for elections.

Minutes of meetings. For years, the Newton Election Commission did not keep regular minutes of its meetings, in violation of the Massachusetts Open Meeting Law. Such minutes are required for the public record and must be made available to anyone asking to see them. The new Commission has been taking minutes and intends to provide such records in the future. Accuracy. The Commission intends to utilize voting procedures and practices that will assure efficiency, accuracy and reliability of the vote count.

The above are just a few of the proposals to be discussed at the next meeting of the Commission, which will be held on Wed Aug 8 at 5:30 pm at Newton City Hall. Meetings are open to the public. ■
